

Terms & Conditions

Turicher.fun (“Turicher”, “us”, “we”, or “our”) an online gaming platform that offers users the chance to win prizes by purchasing tickets for contest participation.

By registering and clicking "I Agree" on www.turicher.fun (the "website") you agree to abide by the following terms and conditions. You agree to our Terms of Service by accessing our website, installing, or using our app. If you do not wish to agree to these terms of use, you must not use the Service. If you are under 18, you are not allowed to use our services.

Privacy Policy and User Data:-

We take your privacy seriously. Turicher's Privacy Policy explains the manner in which we process information, comprising the types of information we obtain and gather from you, and the ways in which we utilize and disseminate that data. You have the responsibility of collecting, using, processing, and sharing your information regardless of where you use our Services. Ticket Generation: - Tickets are generated automatically by our system any time the page refreshed through the Turicher platform. Tickets are non-transferable and cannot be exchanged for cash or any other form of currency.

Deposit Refunds:- If you deposit funds without betting, you will be charged a 2% withdrawal fee for using our services.

Tickets Refunds:- Tickets cannot be refunded once they have been purchased. You will have to wait for the contest to be drawn, either you win and withdraw your funds or loss.

Referrals:- For every friend that you refer and they deposit funds, buy tickets or win contests, you earn certain money as a bonus reward. These are the commissions you get every time your referral:

- Deposit funds: you get 5% commission of every deposit.

- Buy tickets: you get 2% commission of every tickets wagered.
- Win contest: you get 1% commission from the ticket that won.

Wins:- Our distributed computing system utilizes an automated process to randomly select winners, requiring only a few ticket numbers and eliminating manual work, with counting taking seconds.

Loss:- Our distributed computing system utilizes an automated process to randomly select winners, we do not manipulate and do not have access to manipulate draw process. Your loss is a winning to others. You could lose all your funds, therefore we advice you to bet with your spare funds. Only gamble money you afford to lose.

Prizes: - Prizes will be awarded to the winning tickets. We reserves the right to determine the nature and value of prizes for each contest draw.

Fair Play: - Users are expected to participate in Turicher in a fair and sportsmanlike manner. Any attempt to manipulate the ticket generated or disrupt the integrity of Turicher will result in disqualification.

Third-Party Services:-
